ACCURACY OF INFORMATION – Passports are required for departures from Canada. *First and last names on your Reservation Request Form must be exactly as they appear on identification (passport or driver's license). Boarding of airline flights and cruises may be denied if first and last names on the reservation do not exactly match passenger identification.*

AIRLINE FLIGHTS – It is your responsibility to arrange your own transportation to the ship in Vancouver and return from Alaska

CANCELLATIONS – *Cancellation requests must be made in writing to Cruise Holidays and signed by the individual who made payment for the cruise.
